2. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs C Evans, Cllr M Jones (due to illness), Cllr R Davies and Cllr B Williams, Cllr C Jones, Cllr C Banwell

3. ITEM FOR CONSIDERATION

3.1 The Extraordinary Meeting was convened to consider a grant application from the Mini Rugby Club organising committee. These events are as follows:

- A Community challenge on Saturday 4th May, to raise money for the outdoor area in Ynysybwl RFC, creating a safe outdoor play area for children and families to enjoy.
- A bank holiday festival, on Sunday May 26th with live music and entertainment for families.
- Ynysybwl RFC 50th Birthday celebration on Saturday 6th July, hopefully, a free event for all the community to come along too and enjoy, with financial support, the plan would be to have a children's entertainer, live music, bouncy castles, face painter etc.
- The Mini Rugby Organisation have been working hard this past year as volunteers to raise money to be able to put on these events for a minimal fee and when possible, for free so everyone can enjoy a local day out.
- Funds would be used on bread rolls and condiments for the BBQ's, water, sweets for children and the entertainment for families.
- The funding will be used as follows:
 - Rolls and condiments for all 3 events - £150
 - Water for community challenge - £32
 - Sweets for children - £100
 - Family entertainment package - £590

It was PROPOSED by Cllr G Haines to support this event, seconded by Cllr E Wigfall.

It was RESOLVED by council to support this event. **Cllr A Ellis, declared a disclosure of personal interest and did not vote.**
